- Concerns re the size of the proposed domestic garage which is more in keeping with a commercial garage and what the garage will be used for.

Councillor Purple from Burscough Town Council re Speeding on Flax Lane

Items raised included:-

- The road is less than a mile long there are speed limits of national speed limit, 30 mph and 20 mph.
- There are currently no footpaths alongside the road.
- PROW footpath leads on to Flax Lane.
- The road is single track only in the location of the bridge area.
- There are various entrances and exits on Flax Lane.
- Speeding occurring on a regular basis.

The Councillors agreed to support Burscough Town Council and will draft and send a letter concerning the same.
